REMINDER

Subject: Regulating Power consumption for Sector-30 campus of CUG.

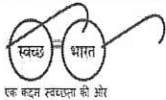
It is observed that of late there have been frequent tripping of power line and damage to the electrical fixtures and installations owing to overload and due to indiscriminate power consumption coupled with extreme heat conditions prevailing in Gandhinagar. Hence, the following mandatory measures for regulation of power consumption are initiated with immediate effect:

1. The Use of Air-Conditioners is restricted and will be available alternatively to the faculty blocks to keep only half of the Air-Conditioners working at any given point of time.
2. The door and curtains of the rooms will be always remained close, while AC is ON.
3. All the Air-Conditioners will be operating at 25°C to 26°C only.
4. For convening the meeting and other academic and co-circular events and functions of general nature, peak hours (12 PM to 4 PM) will have to be avoided.
5. Light and exhaust fans of washrooms should be switch off, when not in use.
6. All the lights in the corridors should be switch off during daytime.
7. It is mandatory and ethical as well to switch off lights, fans and air-conditioners while leaving faculty cabins, offices, classrooms, and other premises.
8. In places of common use like Multi-Purpose Hall, Canteens, ladies room, browsing centers, library, laboratories etc. lights, fans and air conditioners should be used sparingly and optimally.

The above measures are for strict compliance by all and have to be viewed as mandatory.

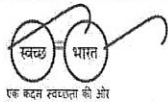
