3. If any candidate has got eligibility on inadvertently wrong information / data than entitled, he / she should bring the same to the notice of the undersigned immediately.
4. **OBC / SC / ST / PwBD / EWS** certificate considered subject to verification.
5. As per Clause no. 57 of the Employment Notification No. CUG/06-1/2022-23 dated 03/10/2022, **“Candidates in their own interest are advised to check regularly the University website www.cug.ac.in. They should also regularly check their email account for updates”**.
