Tej Eye Center is a group of Super Specialty Eye Hospital with centers located at Gandhinagar, Vijay Cross Road (Ahmedabad), Chandkheda, Kalol and Modasa.

**Tej Eye Hospitals** shall provide the following medical facilities to CUG employees & their dependents on CGHS rates to both indoor and outdoor treatments. Please note that only **Lasik surgery** is not covered under CGHS.
