**Sub:** Constitution of Departmental Academic Integrity Panel (DAIP) of Centre for German Studies.

**Ref:** Approval of Hon`ble Chancellor dated 19.10.2023.

As per UGC (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations-2018, the Competent Authority has constituted the DAIP for Centre for German Studies with following members for a period of two years w. e. f. 13.08.2023.

### Centre for German Studies

10 (i) (a)	Chairman-Head of the Department	Chairperson/Coordinator (Ex-officio)
10 (i) (b)	Member - Senior academician from outside the department, to be nominated by the head of HEI.	Prof. Rajesh Makwana, Professor, CGLL, CUG.
10 (i) (c)	Member – A person well versed with anti-plagiarism tools, to be nominated by the Head of the Department	Dr. Sudeep Basu, Assistant Professor, CSSM, CUG.

**Note:** The tenure of the members in respect of points 'b' and 'c' shall be two years. The quorum for meetings shall be two out of three members (including chairman).

### **Terms of Reference:**

1. If any member of the academic community suspects with appropriate proof that a case of plagiarism has happened in any document, he or she shall report it to the Departmental Academic Integrity Panel (DAIP). Upon receipt of such a complaint or allegation the DAIP shall investigate the matter and submit its recommendations to the Institutional Academic Integrity Panel (IAIP) of the HEI.
2. The DAIP shall follow the principles of natural justice while deciding about the allegation of plagiarism against the student, faculty, researcher, and staff.
3. The DAIP shall have the power to assess the level of plagiarism and recommend penalty(ies) accordingly. After investigation, the DAIP shall submit its report with the recommendation on penalties to be imposed to the IAIP within a period of 45 days from the date of receipt of complaint / initiation of the proceedings.
